1. The SEYF General Rules & Regulations apply to this contest.
2. Contest is open to individuals and/or teams.
3. If you are competing in a group, each team member **MUST FILL OUT AN ENTRY FORM.**
4. A Group must consist of two (2) or more contestants representing a club or chapter. No points will be awarded for Group entries towards “Youth Conservationist of the Year.”
5. Contestants must use a 20” x 26” x 6” plastic tray. Trays may be borrowed or purchased from the Sponsor or from Lowes/Home Depot. Borrowed trays will require a deposit of \$10.00.
6. All entries must be identified on the side of the tray with the following information:
 - a. Individual or group name
 - b. 4-H Club or FFA/FCCLA Chapter
 - c. Age
 - d. Division (Junior, Intermediate, Senior or Group)
7. Model landscape from any suitable material. (Contact Show Coordinator if you have questions.)
8. All entries must use materials that will last ten (10) days without replacement.
9. Trays should be easy to lift, move and NOT be excessively heavy.
10. All items must be securely fastened. Neither the SEYF nor the MSWCD will be responsible for missing or broken items.
11. Exhibits brought in after the check-in day and time will not be accepted.
12. Exhibits and awards not picked up on the day and time listed above will be forfeited and become the property of the SEYF.
13. The Show Coordinator will contact the winners with the date and time of the Marion SWCD’s Awards Night.

JUDGING

14. MSWCD will designate three (3) judges to evaluate entries based on the following criteria:

a. Appearance – neatness, materials used & overall workmanship	33 points
b. Authenticity – scale, effective use of the practice listed on tray	33 points
c. Conservation practices – effectively using a MINIMUM of three (3); however, more than three (3) are encouraged. Practices must be obvious to the viewer and neatly labeled.	33 points
d. Following rule #5.	1 point
