- 1. The SEYF General Rules & Regulations apply to this show.
- 2. There is a mandatory meeting for all participants in the rabbit show.
- 3. All exhibitors must be 5 -7 years old as of September 1, 2017.
- 4. Exhibits will be for display only, they will not be judged.
- 5. Worksheets due at check in. Available at SEYF website. Seyfair.com
- 6. Exhibitors will be allowed to show one of the following:

Mini Rex - Netherland Dwarf - Holland Lop - Dwarf Hotot - Jersey Wooly American Fuzzy Lop - Havana - Dutch - Himalayan - Lion Head - Mini Satan Polish - Cavy (any ARBA accepted breed)\*

- 7. Once entries are received any substitution must be submitted by written **and** verbal notice to the Coordinator by December 3, 2017. **Linda Graham, 352 445-4552, P.O. Box 6749, Ocala, FI 34478**
- 8. All rabbits must be entered by individuals, no club entries allowed.
- 9. All rabbits must be 5 months of age at time of show.
- 10. No pregnant rabbits may be entered.
- 11. Mixed breed rabbits will not be allowed.
- 12. The Fair reserves the right to remove any animal for biting during the exhibit time.
- 13. The SEYF provides cages, feeders, feed and water during show.
- 14. Once checked in, no rabbits may be removed until the pick-up date without the consent of the Show Coordinator. A \$10.00 fee per animal will be charged for any special arrangements requested.
- 15. Exhibitors rabbits not picked up on the day and times listed above will be charged a \$25.00 per day fee up to three days at which time awards will be forfeited and rabbits will become the property of the SEYF.
- 16. At time of pick up exhibitors are responsible for cleaning the feeders and cups before checking out.

#### **HEALTH REOUIREMENTS**

17. All rabbits will be checked for external parasites and or diseases. Any rabbits failing inspection must be removed immediately from the fair grounds.

#### **SALE OF ANIMALS**

- 18. Anyone wishing to sell their animals should notify the Show Coordinator upon check-in. There will be a tag placed on the cage stating that the animal is for sale with the price.
- 19. All animals sales and transactions will be done through the coordinator. A 10% commission to the SEYF will be deducted before payment is made to the exhibitor at check out.

### **PICK UP OF ANIMALS\***

- 20. **Mandatory thank you letters** are required at check-out in self-addressed stamped envelopes according to the required list given at check-in.
- 21. All water and feed are to be discarded in marked containers; feeders, water bottles and crocks are to be placed in the marked plastic containers.
- 22. Pull all clips and pins used to hold cups and tags to the check-out table and place in marked container.
- 23. Take all animals and the exhibit tags to the designated check-out area to pick up check-out packet and sign-out animals.
- 24. All sale animals must be brought to the check-out table before leaving the barn with the exhibitor tag.
