

# 2023 SOUTHEASTERN YOUTH FAIR LEASE AGREEMENT FOR BEEF HEIFER/COW

To provide qualified, hard-working 4H and FFA youth who either lack the means and/or the facilities, with greater opportunity to gain Hands-on learning experience with an animal to be shown at the 2023 Southeastern Youth Fair.

## Rules:

1. The lease program is available only to youth, hereafter referred to as lessee, which are in good standing with their local 4H/FFA club or chapter. The lessee must attend regular club/chapter meetings.
2. All leased animals must be bon-a-fide 4H or FFA projects.
3. Project record books must be kept on each animal throughout the lease agreement.
4. **The leased animal must be under the care and responsibility of the lessee by November 18, 2022, in order to show in the 2023 Southeastern Youth Fair.**
5. A Heifer/ Cow must be shown by the same Exhibitor each year, unless the said heifer/cow was not shown the previous year.
6. The title of ownership is to remain in the possession of the owner of the animal, hereafter referred to as sponsor.
7. The sponsor agrees not to hold lessee responsible for any financial loss due to injury or death of the leased animal.
8. The sponsor is not responsible for financial liability due to any injury or loss, which the lessee or the lessee's parent/guardian may incur while involved in working with the leased animal.
9. The lease agreement must be signed by the owner of the leased animal (sponsor) the lessee (youth participant), the lessee's parent/guardian, and the lessee's club or chapter leader.
10. The lease agreement must be approved by the SEYF Show Division Coordinator in order for the youth to show the leased animal at the 2023 Southeastern Youth Fair.
