1. The SEYF General Rules & Regulations apply to this show.
 2. All exhibitors MUST complete the Mandatory Online Training by the deadline posted on the Calendar of Events and show proof with Certificate of Completion if they wish to participate. All Market Animal Entry forms are due by the deadline posted on the Calendar of Events (on the seyfair.com website).
 3. Scrapie tag is required for animal identification. See Animal Inspection Rules 5C-4.055 goats or sheep. **ALL ANIMALS ARE REQUIRED TO HAVE A CURRENT VETERINARIAN HEALTH CERTIFICATE ON SHOW DAY. Veterinarians will be available at check-in, however a charge of \$5.00 cash only will be required. If you do not have cash – you will be asked to leave the line and get cash and go to the back of the line.**
 4. NO OPEN WOUNDS AT INITIAL OR FINAL WEIGH-IN. No fresh cut horns or castration wounds. Wounds MUST be completely healed.
 5. Market Wethers will only be shown in the Market class. Wethers ONLY in Market class, NO bucks, NO does. Market wethers must be born prior to October 1, 2024. PYGMY Goats DO NOT have a separate class. They must meet 45 lb. minimum weight requirement **and must be one year old or younger.**
 6. No exhibitor may enter more than one animal per class. **Exhibitor can only show one market goat.**
 7. NO HORNS ALLOWED ON MARKET WETHERS.
 8. See Calendar of Events for dates of when Record books are due to be turned in to the SEYF office.

TAGGING DAY

You must bring the market goat to the Livestock Pavilion on Wednesday, **October 30, 2024 from 4-6:30pm** to have it tagged and weighed.

SHOW DAY

9. ALL MARKET WETHERS ARE REQUIRED TO COMPLETE A MARKET ANIMAL BOOK to be turned in by deadline posted on the Calendar of Events, with the EXCEPTION of the Financial Summary page which will be turned in on show day.
10. Failure to have an animal under control will result in disqualification.
11. Animal should be clean and have neatly trimmed hooves.
12. All Market Wethers should be clipped.
13. Exhibitor must wear the official dress of his/her organization. (see General Rules #24)

SHEARING/CLIPPING

All clipping done on fairgrounds must be done outside of the livestock barn. No shearing or clipping will be allowed inside stalls or barn aisles. Areas under the West stands and behind the barn will be used for this.

CLASSES

14. The Show Coordinators reserve the right to combine or divide classes as necessary for the benefit of the overall show.
15. Market Classes will be determined after Final Weigh-In.
16. **All Market Goats will be consigned to the sale. No exceptions.**

Market Sale Wethers:

45 pound minimum weight
(ALL market wethers regardless of breed)
