

Southeastern Youth Fair - Lamb, Swine, Steer, Goat Auctions

Bidder Registration Form

Terms and Conditions:

1. These auctions are defined as market class sales pursuant to Chapter 5C-4, Florida Administrative Code, "Admission of Animals for Exhibition."
2. All lots sold will be processed for consumption and may not be taken from the premises for any other purpose. *Lambs and goats are exempt, however if buyer is "keeping" lamb/goat, the animal must be taken from premises immediately after the final animal is sold.*
3. Each sale lot will be sold separately to the highest bidder. Bidders must use their assigned bidder number in order to be recognized.
4. The auctioneer selling will settle any disputes as to bids by declaring all bids off and reselling the animal in question.
5. Each animal will be at seller's risk until sold, but as soon as sold will be at buyer's risk.
6. This association acts only as an agent for the lamb/hog/steer/goat exhibitors and assumes no liability, legal or otherwise, to the public in general or to the buyer and seller.
7. **Payment is due immediately following the conclusion of the auction.** Payment can be made by cash, check, or credit card. Payments can be made at the Payment Office located directly behind the stage after you have received/signed your invoice. Payment can also be delivered to the SEYF office **within 30 days of the sale.** The exhibitor will not be paid until the money for their animal has been received by the SEYF. *If payment is not made within 30 days, buyer will be required to submit credit card information before auction for all future SEYF sales.*
8. **Choice of processor on each lot's sale slip is FINAL. Choice of processor made on internet sale is final. Southeastern Youth Fair makes no guarantee for processor changes after the sale slip is marked and signed during the auction.** The highest bidder (purchaser) must choose to do one of the following options on each lot's sale slip. Your choices will be one of the below options:
 - **RESALE** the lamb/hog/steer/goat to the buy back agent for the resale price established through bid process at the onset of the auction.
